This typically results in a reduction of about 15-20% in annual savings.

Tanya has extensive experience on RAD transactions including but not limited to, Transfer of Assistance projects, RAD Blend (75/25), RAD with PBV, RAD with de minimus units, RAD with Reserves & RAD with LIHTC. To date, she has closed almost 3,000 units over 40 projects. In addition, she has conducted dozens of RAD feasibility studies for agencies, nationwide, submitted dozens of RAD applications.
